## Annual Business Meeting – February 6, 2010

The annual business meeting for the chapter will be held on February 6<sup>th</sup> at 10:00 at the Washington State historical Society Museum in Tacoma. The business meeting will begin at 10:00 followed by a presentation by Portland author John C. Jackson, who is quoted as being “half bear, half pussy cat,” and is co-author of “Meriwether Lewis” with Thomas Danisi. (See page 35 of the November 2009 WPO for a brief description.) Jackson is a graphic designer and author who follows the Jackson family creed of “always tell the truth no matter who gets hurt!” His exhaustive research has led him and Danisi to write possibly the best biography of Lewis to date. He has also written books about the Metis in the Pacific Northwest, Piikani Blackfeet of the Northern Plains, Indian Wars and Indian Politics. He is currently editing a history of the “North West Company Columbia Adventure” for his late friend Lloyd Keith.

Plan on attending this annual meeting, if you can. The business meeting will start at 10:00 and include nominations and elections of new officers, reports and any chapter business that needs attending. Mr. Jackson will give his presentation immediately after and should finish before noon, depending on the number of questions, of course!

Following the chapter meeting at about 1:30, the State Governors Lewis and Clark Committee will hold their meeting in the same location as the chapter meeting. Chapter members are welcomed and encouraged to attend this meeting, as well. However, you will most likely want to bring a lunch if you stay since there is a lack of eating establishments in the immediate area.

### International Context of the Expedition: Four Nations Vie for Northwest Lands

On Saturday, January 30<sup>th</sup>, the Oregon chapter is hosting a presentation by University of Portland professor Dr. Mark Eifler in which he will describe how the PNW was a hotbed of International competition between 1775 and 1815 as four nations – Spain, Russia, Great Britain and the United States – sought control of the region. The quest for furs was not the real reason behind these expeditions to the North Pacific coast of North America. There were great geopolitical ramifications that took greater precedence.

The talk will be held at 10:00 in 301 Shiley Hall (the Engineering Bldg.) on the Univ. of Portland campus.

Following the talk, participants will walk to the monument on the “bluff” that honors four members of the Expedition. A lunch gathering will follow in a local “pub” where the last remnants of the 1905 Lewis and Clark International Exposition can be seen. It should be a fun event!
